n November 2018, the Avery Coonley School Board of Trustees approved the "Inspiring Excellence: A Strategic Plan for ACS." This living document was carefully crafted to guide decision-making and programmatic changes over the next several years of the School's existence. The first of its four goals is to "Deepen our commitment to our gifted mission and program." Within that goal, the first objective focuses on happiness, specifically directing our faculty, staff, and curriculum to nurture gifted children to become happy, engaged, lifelong learners. Merriam-Webster defines happiness as "a state of well-being and contentment." This definition seems simple enough, but creating actionable items to move the community towards achieving this goal is more complicated.

The approach to defining and promoting happiness is multifaceted. During the 2019-2020 school year, ACS counselors Meghan McCarthy and Angel Van Howe worked closely with division heads, students, and faculty to create a Social Emotional Learning framework, also known as SEL. The framework provides learning expectations that vary based upon the developmental level of the students. It also provides teachers with a clear and common language to help students navigate classroom interactions, recess confrontations, and lunchroom discussions. Be respectful. Be engaged. Be mindful. These principles guide the specific behavioral expectations. The intention is to create a state of well-being and contentment for the entire community of learners. Knowing what is expected of them and how best to live out those expectations creates a sense of accomplishment while simultaneously improving student contentment.

While generally used as a time of rest and reflection, the summer of 2020 brought planning and preparation for the Return to Learn Plan. The administrators and staff instead were bustling about the building implementing massive changes to physical spaces. Simultaneously, teachers reimagined curriculum delivery for social distancing, mask-wearing, and the possibility of remote learning.

Additionally, every adult in the building knew that it was more important than ever to show up for the students with a growth mindset and joyfulness during this time of uncertainty and worry. In keeping with the Strategic Plan, and under the direction of Lisa Wiltz, the entire faculty and staff returned to school to engage in learning through a program called The Orange Frog. This professional development course is based upon Shawn Anchor's Happiness Advantage and is used by educational organizations worldwide to teach the impact of positive psychology. Shawn Anchor's 2011 TED Talk explained, "Your brain at 'positive' is 30% more productive than your brain at negative, neutral, or stressed."

Happiness is not on the other side of success, but rather, the mindset that helps you achieve it. The Orange Frog program posits that we can retrain our brains by expressing gratitude, physical exercise, and meditation. Faculty were taught WHY positivity matters, and HOW to achieve it, for themselves and their students.

At The Avery Coonley School, happiness has a trickle-down effect. If administrators lead with happiness and gratitude, faculty and staff will be inspired to teach and lead with happiness and gratitude. Subsequently, students will learn and grow in happiness and gratitude.

Amidst all the change, the reminder to be respectful, be engaged, and be mindful guides students in their learning journey. Positive psychology also encourages us to share our joy with others, celebrate progress, express gratitude, and take time for self-care. With that, ACS is excited to have made measurable progress towards achieving the 2018 Strategic Plan's goals, including improving students' social emotional health and happiness.

n early March, Student Council surprised ACS students with an announcement that the 2020 Auction Fund-A-Need would focus on expanding the existing playground. More than just an announcement, it was an invitation for students to help select the new equipment. Both lower and middle school students were eager to share ideas about what they would like to see added. They imagined how fun the new area would be during recess, before school, and after school. Less than ten days later, what students knew as a "normal" school day changed dramatically. Uncertain of what the remaining school year would hold, let alone the next school year, students and staff persevered to achieve the newly envisioned goal. With the in-person school year coming to an abrupt close, the playground expansion project became a symbol of hope during a time of great uncertainty. Rallying around the students, the ACS community opened their hearts and wallets at the first-ever Virtual ACS Auction and generously donated \$69,579 for the project.

Raising funds was only the first step in securing the much-anticipated playground expansion. The next step was to prepare the area for the new equipment. Adding approximately 4,500 square feet to the play area – nearly doubling the playground's size – required significant landscaping and construction affecting the soccer field and adjacent sidewalk. Truckloads of dirt, mulch, and wood timbers were brought in over the summer to expand its footprint. The soccer field was rotated 90 degrees to run north/south, and new benches were built alongside the playground retaining wall. A new sidewalk path now connects the blacktop to the Makerspace annex (also known as The Barn).

Last but not least was the installation of the new play equipment. In addition to the student ideas shared in March, the Student Council was pivotal in providing feedback on the latest equipment. The most popular requests included swings, slides, and monkey bars – all of which were added to the playground!

Students can now play on a new multipiece playground structure with slides, climbers, and monkey bars and rings, complete with an overhead shade. Two traditional swings, two tire swings, a motion spinner, and large outdoor chimes completed the new addition. Thank you to the Student Council and the generous supporters listed on page 42 whose contributions brought this project to reality for ACS students!

This year, as COVID-19 cases increased throughout the nation, so did the need for protective equipment and financial support for various communities. The Avery Coonley School community stepped up and took action to help others during this difficult time.

When COVID-19 hit, there was an immediate need for more personal protective equipment (PPE). Many members of The Avery Coonley School came together to help those on the frontline. Three young alums, Adam Kipp '19, Alex Turk '17, and Christian Turk '19, created and delivered masks and headgear for medical personnel and others in need. Adam Kipp is the Founder of the Protect Our Community Group (POCG2020), which provides PPE to medical and non-medical people as protection from COVID-19.

His group donated over 2,000 masks and other supplies to hospitals and senior citizens. Alex and Christian Turk started F.A.C.E (Fighting Against COVID-19 Exposure), with two 3D printers donated by Chess ED. Their group has donated more than 1,500 face shields to hospitals, nursing homes, hospices, and doctors' offices.

While ACS alumni were hard at work providing protective equipment to frontline workers, The Avery Coonley School joined TinkRworks on another project. Together they offered equipment to first responders and medical professionals by utilizing 3D printers and laser cutters to create protective face shields. The partnership with TinkRworks began more than two years ago when they collaborated to build the first Makerspace at The Avery Coonley School. This partnership evolved from supporting curriculum and instruction to helping the greater community in its time of need.

The Makerspace transformed into a workshop for PPE equipment. Through this collaboration, ACS, TinkRworks, and Brookfield District 95 created around 60-65 face shields each day of production. The school's 3D printers were used to fabricate headbands and chin supports. Then, overhead transparencies were laser cut for the shield. Once assembled, the face shields were distributed to first responders at the Aurora Fire Department, Brookfield Police Department and Fire Department, La Grange Park Police Department and Fire Department, Riverside Police Department and Fire Department. They were also distributed to medical professionals, including respiratory therapists, and were delivered to Hines VA, Loyola Hospital, and The Chicago Fire Department.



The local healthcare industry was still in desperate need of N95 masks, face shields, protective eyewear, shoe covers, and more. Faculty, staff, and parents were encouraged to donate protective gear to support a current parent working at Edward Hospital and their fellow medical staff. Current ACS parent, Fei Dong, worked with the ACS administration to reach out to other parents in their class to establish a donation bin on campus. Families donated extra materials safely and securely that were then delivered quickly to those working at the Edward Hospital.

Support from The Avery Coonley School community did not stop there. During this time, The Avery Coonley School also created the COVID-19 Emergency Assistance Fund. The fund provided tuition assistance to ensure that students whose family faced financial hardship due to COVID-19 could return for the 2020-2021 school year. The COVID-19 Emergency Assistance Fund was an avenue for those in a position to help financially. The outpouring of support was incredible, though not surprising. Members of the ACS Board of Trustees personally pledged \$50,000. In total, \$225,143 was raised for this important fund through donations and the ACS Annual Auction. Families began applying for and receiving funds in August for the 2020-2021 school year. Despite the uncertainty, ACS remained generous, compassionate, and resilient.

This year, the Avery Coonley School took a strategic approach to the fall semester. With the COVID-19 pandemic undeniably impacting their 2020-2021 school year plans, ACS took every necessary precaution to create a safe learning environment for its students and staff. In June, Head of School, Paul Druzinsky and his administrative leadership team began preparation. The first step was to create two task forces to devise a plan that would allow for a safe return to campus in August.

These task forces spent many hours researching and meeting to first determine feasibility then provide guidance and direction about returning to campus. The SAFE ACS Task Force addressed health and safety procedures, while the Academic Continuity and Scheduling Task Force addressed academic and scheduling details. The task force members included representation from current ACS parents, students, faculty, staff, and medical professionals. Based on the committees' work and recommendations, The Avery Coonley School announced it would fully reopen for in-person learning five days per week for the 2020-2021 school year. To ensure all community members remained informed, The Avery Coonley School created and launched the ACS Return to Learn Plan on August 3, 2020, which included protocols, safety procedures, and guidelines. From staggered drop-off and pick-up times to temperature taking to a rotating schedule for outdoor learning, every part of the day was evaluated for how to keep students and faculty safe.

As a part of the extensive plan, the school received many renovations and changes to classrooms and outdoor spaces. Under the supervision of Peter Brown, Chief Financial Officer and Assistant Head of School, and Andrew McCormick, Director of Maintenance, the school saw the addition of socially distanced desks with plexiglass barriers, UV lights, HVAC equipment to improve airflow, indoor and outdoor handwashing stations, hand sanitizing stations, speakers and audio support to accommodate mask-wearing, technology for students and teachers for outdoor or remote learning, hands-free faucets in bathrooms, enhanced nurse's station, and more. The task forces and staff went above and beyond to create redundancies that would keep students safe, and help families feel comfortable returning to campus.

Driven by the motivation to have inperson learning once again, The Avery Coonley School confidently re-opened its doors on August 27, 2020. What felt like the finish line, was really only the beginning. With so many changes, there were bound to be challenges and frustrations. In response, faculty and staff were nimble and creative in their problem-solving. Only a few weeks into the school year, everyone is becoming more comfortable and familiar with the changes.




## 2019 - 2020 Annual Report

haritable giving supports the life of The Avery Coonley School and our students on a daily basis. It is evident in the classrooms, where small groups of students, highly-trained faculty, an innovative curriculum, and technology all interact in magical ways. It is seen in the rich offerings of the arts, physical education, and extracurricular activities that address the development of the whole child. Philanthropic support makes possible the remarkable array of physical spaces of this beautiful and historic campus. It is in the school pride and spirit that build a strong and welcoming community. It is in the financial aid that ensures that an ACS education can be within the reach of as many families as possible. All of this, and more, is made possible by the contributors acknowledged in this Annual Report.

Each year, the School conducts two major fundraising initiatives that are led by the Development Office: the ACS Fund and the Annual Auction. With the COVID-19 pandemic in full swing and distance learning in place for all ACS students, proceeds from the 2020 Annual Auction were dedicated to support the COVID-19 Emergency Assistance Fund. This fund provided financial tuition assistance to ensure that every ACS student was be able to return for the 2020-2021 school year, despite financial hardship caused by the pandemic. All monies raised from the Silent Auction, Party Boutiques, and Class Basket Raffles were directed toward this Fund.

Charitable gifts to the School may also be directed to one of three major endowment funds: the General Endowment, which supports a wide range of School needs; the Professional Growth Endowment, which provides vital resources for the ongoing professional development of faculty; and the Financial Aid Endowment, which supports the goal of broadening access for qualified students of all socio-economic backgrounds. The tradition of philanthropy started by Queene Ferry Coonley continues to be a vital part of the success and well-being of ACS. ## Revenue and Support

#### Tuition Income Less Need Based Financial Aid

#### \$7,604,052

Full tuition is charged to all students who attend the School. ACS awards financial aid to qualified recipients based on financial need calculated by School and Student Services (SSS), managed by the National Association of Independent Schools (NAIS). Partial financial aid was awarded to 58 students during the 2019-2020 school year.

#### ACS Fund and Other Gifts

#### \$396,857 The ACS Fund is generous charitable support from current parents, alumni, grandparents and other friends of the School to help pay the additional expenses not covered by tuition.

#### Auction

Net proceeds from the ACS Annual Auction helps bridge the gap between what tuition covers and the actual costs of educating students at ACS. Currently, the gap is \$3,693 per student.

#### Programs and Fees

#### Net income from the After School Program, Summer Program, milk fees, testing services, and new student fees assist with paying for the variety of addition programs and services offered by ACS.

#### Investment Income

Income earned on operating cash, designated cash, and a portion of the interest earned on the endowment.

Facilities Rental and Miscellaneous Income

Net revenue generated from the rental of school facilities and other programs sponsored by the School.

Educational Salaries and Benefits

#### **Building Maintenance**

Contracted maintenance services including custodial, landscape services, snow removal, utilities, maintenance supplies, and repair costs.

#### **Educational Expenses**

Expenses related to instruction including educational software, curricular materials, textbooks, technology equipment, classroom supplies, educational professional growth, standardized testing costs, as well as spending to fulfill requirements of temporarily restricted donations.


#### Administrative Expenses

#### Debt Service and Depreciation

The Village of Downers Grove issued Revenue Bonds on the school's behalf. The principal and interest payments represent the current cash outlay to cover the Middle School addition and a portion of the Lower School renovations. Depreciation is also included.




Students wave to the Head of School, Paul Druzinsky, as he prepares to do his annual reading of "The Giving Tree" by Shel Silverstein.

# Thank You

In 2019-2020, we said farewell to several faculty and staff members who retired. We wish them well and thank them for their service.

Jan Ciampi, Group 4 Teacher, arrived at ACS in 2010. Her sharp wit and direct humor resonated with many students at ACS. As a Group 4 teacher, her love for math and science was undeniable. Her passion for math helped guide the Group 4 students to victory as they won several Continental Math League competitions under her leadership. She also introduced a hands-on architecture unit into the curriculum, which nicely paired with ACS's connection to Frank Lloyd Wright and the school's early roots. She encouraged her students to understand concepts and demonstrate their discoveries with others. Jan's students loved her humor and impromptu dance parties; even previous students would routinely come back to visit her. She was a mentor to many, and we are grateful for the time and effort she devoted to helping others succeed.





Dave Dundek, Middle School Social Studies and Summer Program Director, arrived at ACS in 1992, just a few years after ACS expanded their classes from 25 to 32 students per group, and he joined alongside Anna Lenhardt as a Group 5 homeroom teacher. He was always eager to collaborate and welcomed the opportunity to plan projects that integrated language arts with world history. When the Middle School advisory program was created in the mid-1990s, Dave enthusiastically volunteered to be on the planning committee. He has been a dedicated Group 5 advisor ever since. As the Director of the Summer Program for more than 25 years, Dave grew its enrollment and reputation within the community. 
